NOTICE

Two-day's Facilitation Camp is scheduled to be organized by Department of Social Justice & Empowerment (DoSJE) at Dr. Ambedkar International Centre (DAIC) New Delhi from 16.01.2025 to 17.01.2025 (from 10.00 am to 5.30 pm) to address the concerns/grievances of the Training Institutes (TIs) / Training Partners (TPs) which had submitted applications for empanelment under PM-DAKSH Scheme for the year 2024-25 against the Expression of Interest (EoI) floated on 05.06.2024.

2. For attending the said camp, it is pre-requisite on the part of the intending TIs/TPs that the Office Bearer of the TIs/TPs would carry an authorisation letter by the Organization and a photo ID of individual along with a copy of the complete application (including all annexures) originally submitted by them against the EoI floated by DoSJE.

3. In the said camp, the TIs/TPs would be informed about the outcome/decision taken on their applications, i.e. whether their institutes/centres have been empanelled under the said scheme and in case, the TPs/TIs are not selected, the reasons/grounds thereof would also be provided.

4. However, if the TIs/TPs are not satisfied with the decision of DOSJE on their application and intend to scrutinize their original application again and the statement/details relating to them having been placed before the Project Appraisal Committee constituted for scrutinizing the applications received from TIs/TPs, they need to submit an affidavit duly notarized on Rs. 100 stamp paper in the format enclosed herewith.
