3.0 PRE-ALIFICATION REQUIREMENTS:

PCR CONDITION-I:

1. The bidder should have completed any civil construction/Building work within last (7) seven years prior to the original schedule date of tender opening in any Government/Quasi-Government/PSU/PSE/Public limited company in their own name/in the name of any one of the partners, as given below:
 - a. One work of completed value not less than **Rs. 49,27,167.83/- without GST** in a single Contract Agreement/Work order.
(OR)
 - b. Two works of completed value each not less than **Rs. 30,79,479.89/- without GST** in two Contract Agreements/Work orders.
(OR)
 - c. Three works of completed value each not less than **Rs. 24,63,583.94/- without GST** in three Contract Agreements/Work orders.

2. Financial Criteria:

- i. a). Average Annual turnover of the bidder for the 3 financial years immediately preceding the original scheduled Tender Opening date should not be less than **Rs. 74,93,000.00.**
- b). In case, if a bidder meets the technical QR but could not furnish **his/their audited financial statement (certified audited balance sheets) or a certificate from the chartered accountant appointed in DIN N indicating the turnover details** of three consecutive financial years preceding the last financial year for evaluating the average Annual turnover, due to the incorporation / formation of the bidder, within a period of less than 3 years from the original scheduled date of tender opening, then, such bidder shall also be considered and the Average annual turnover of such bidder shall be arrived at as below:
 - If the bidder furnished audited financial statement (Profit & Loss Account and Balance Sheet) or a certificate from the Chartered Accountant's Cost Accountant containin UDIN N . indicating the turnover details for the last financial year only, then such bidder's average Annual turnover shall be arrived at by dividing the Turnover of the last financial year by three.
 - If the bidder furnished audited financial statement (Profit & Loss Account and Balance Sheet) or a certificate from the Chartered Accountant's Cost Accountant containin **ils** for the last two financial

years only, then the bidder's average Annual turnover shall be arrived at by dividing the sum of Turnover of last two financial years by three.

- ii. The Bidder shall have positive Net worth as per their latest audited financial statement or as per certificate from the Chartered accountant/Cost accountant (containing UDIN No.) issued for net worth calculation.
 - iii. In cases, where audited financial statement (Profit & Loss Account and Balance Sheet) or certificate from the Chartered accountant/Cost accountant (containing UDIN No.) indicating the turnover details for the last financial year immediately preceding the original schedule date of Tender opening are not available, a certificate would be required from the bidder stating that the Financial statement of the bidder is under audit/return filing process as on the date of tender opening. In such case, the audited financial statement of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
3. The following documents or relevant documentary evidences so as to meet the above stipulated PQR conditions are to be furnished along with the bid without fail. Otherwise, the offer is liable for rejection.
- i. Copy of Workorder or LOA or Agreement.
 - ii. Copy of end user execution/completion certificate/finalization order for the work executed/completed/finalized indicating the name of work, LOA/ Agt. No./period of work and finalized/completed/executed value of work.
4. **Conditions w.r.t. partnership firm:**
- i. In case of bid submitted by any partnership firm, the pre-qualification work experience of partnership firm / any of the Partners of the firm shall be considered for evaluation. However, the financial Turn Over and Net Worth requirement, if any specified shall be fulfilled by the Partnership firm only.
 - ii. If the bidder is a partnership firm, the partner on whose pre-qualification the work was awarded, shall not withdraw from the partnership till the completion of the work in case they happened to be the successful bidder. If there is any reconstitution of the partnership, it is the responsibility of the firm to intimate the same to NLCIL immediately. Otherwise, the contract will be liable for termination at the risk & cost of the contractor.
 - iii. If the work experience is furnished in the name of any of the partner of Partnership Firm, to satisfy the prescribed pre-qualification requirement in the tender, a declaration / undertaking from that partner as "I shall not withdraw from the partnership till the completion of the work, in case our firm happened to be the successful bidder" is to be enclosed along with the bid in Cover-I.
 - iv. In case of a bidder being a partnership firm and using the PQR of a Partner to qualify in the tender and if the bidders using

- v. In case, a bid is submitted by a partnership firm, any partner(s) of that Partnership firm cannot bid separately for the same Tender. If the Bid is submitted by both the partnership firm & any partner(s) of that Partnership firm in the same tender, the bids of the Partnership firm and partner(s) will be disqualified.
5. The bidder shall be a proprietary firm/ partnership firm/ a firm (private, Public, Govt.) registered under company Act/Society registered under society Act.

PQR CONDITION-II:

- i. The bidder should have independent Provident Fund Code Number allotted in favour of his establishment under EPF & Misc. Provisions Act 1952. The PF code number so allotted shall be furnished with documentary proof along with Tender documents.
- ii. The bidder should have registered (its establishment) under ESI Act 1948 and have the Employer's code allotted in favour of his establishment. The ESI code number so allotted shall be furnished along with the tender documents.
- iii. The personnel/Workmen engaged by the bidder for execution of works in NLCIL under the contract shall be in the rolls of the bidder agency and shall have to be given appointment letter / Employment Card under CL (R & A) Act 1970 issued by the bidder to that effect. The bidder has to furnish a certificate of undertaking to that effect, along with Tender documents.
- iv. The bidder shall also possess a valid certificate of registration under Goods and Services tax (GST) Act/Rules; he should have discharged his liability, under the Service to the effect of which a certificate of undertaking is to be furnished along with Tender documents.
- v. The bidder should have obtained Permanent Account Number (PAN) under the Income Tax Act and the documentary proof shall be furnished along with tender. It is mandatory to provide the self-attested printout of the online IT statement indicating his Zero Tax Liabilities for four consecutive years prior to bidding along with the tender documents.

Note:

- i. Documentary evidence for compliance of the above should be furnished along with Part-I Cover.
- ii. In case of the bidder's annual turnover in the previous years is less than Rs. 20 lakhs, the bidder has to furnish an undertaking to that instead of GST registration.

DOCUMENTARY PROOF:

Documentary proof in the form of copies of documentary evidence for the above should be furnished/attached along with Bid in **Part-I cover** for pre qualifying requirements. *In case of partnership firms, the partnership deed should have been executed prior to the date of original scheduled opening of tender NIT date.*
