- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

# Tender Activities Description for GeM: Comprehensive Self-Defence Training Programme

# Title:

Comprehensive Self-Defence Training Programme for Female Students under PM-USHA at Government Polytechnic, Gadchiroli

## **Scope of Work:**

#### 1. Course Execution & Structure:

- The training shall follow a **standardized syllabus aligned with the DPR** and strictly adhere to all norms of **PM-USHA** and **UGC**.
- Duration for each participant: 6 months (3 months Basic + 3 months Advanced).
- > One cohort consists of 2 batches, each with 25 female students aged 18 to 23 years.
- > Training is planned to start from 1 September 2025.

# 2. Batch Planning & Distribution:

- First 3 Months: Basic Self-Defence training for all 50 participants.
- Next 3 Months: Participants are equitably divided into 4 groups, each undergoing one of the following advanced specialization courses:
  - 1. Foundation of Karate
  - 2. Judo Mastery
  - 3. Taekwondo
  - 4. Kickboxing
- ➤ Each advanced-level course will be conducted by a **dedicated instructor** and run concurrently.
- > Over 2 years, the programme will run 4 batches (2 batches/year).

# 3. Training Hours & Costs:

Each batch: 12 hours of theory + 42 hours of practical per month

# 4. Trainer Requirements:

- ➤ All trainers must have a minimum of 3 years of experience.
- Each advanced-level course must have **one dedicated trainer**.
- > At least 50% of the total trainers must be female.
- For all-female batches, a **female instructor is mandatory**.
- Agency must submit an **affidavit** declaring **no criminal cases** against any of its personnel.

#### 5. Modules Covered:

- **Basic Training:** Foundational physical education, situational awareness, safety drills
- > Advanced Training:
  - Foundation of Karate: Stances, strikes, blocks, self-discipline, etc.
  - Judo Mastery: Throws, grapples, takedowns, breakfalls, etc.
  - Taekwondo: Sparring, kicks, balance and control, etc.
  - **Kickboxing**: Defensive tactics, cardio training, striking techniques, etc.

# 6. Language & Location:

- ➤ **Medium of instruction**: Marathi/Hindi
- > Training will be conducted at Government Polytechnic, Gadchiroli
- ➤ No residential accommodation will be provided

# 7. Documentation & Monitoring:

- > The agency will be responsible for:
  - Registration of students
  - Attendance logs
  - Monthly progress reports
  - Examination and certification records

#### 8. Certification:

- ➤ Upon successful completion of the full 6-month training, certificates will be issued jointly by:
  - PM-USHA

 Recognized Karate/Martial Arts Association affiliated with the Government of Maharashtra

# 9. Advertisement & Awareness:

- > The agency must publicize the programme via:
  - Local banners and hoardings
  - Flyers within campus and public spaces
  - Newspaper advertisements (Marathi regional dailies)

# 10. Payment Terms:

- > No advance payment shall be made.
- ➤ Remuneration will be released every month upon successful completion of the approved monthly teaching plan. Subject to submission of all necessary documentation and participant certification.
- ➤ All payment will be processed via **SNS SPARSH portal**.
- ➤ Payment is subject to availability of funds and decisions by the Maharashtra State and Central Government.
