1. Background

A Centre for Career Guidance was started by putting three things together a classroom cum study centre, a mechanism to enable students and teachers' participation and an organizational setup to run and support the entire programme with the following objectives:

- 1. To supplement the sincere efforts of the Government in providing coaching to aspirants preparing for various competitive examinations (Banking, SSC, and ADRE)
- 2. To set up a classroom for career guidance aimed at recruitment to prestigious Govt. posts and also to secure a seat to increase recruitment of people from construction workers community of the state and to bring in the voice of people from the community to the decision making tables of the Government.
- 3. To provide a platform to youth and students for Interaction with administrators, successful entrepreneurs, academicians and others and to reach out to students in far flung areas of the state for promoting better career choices among them.
- 4. To integrate the resources available and make these accessible to the aspiring youths of the construction workers community.
- 5. Coaching facility may be provided at minimum of 5-6 locations in different districts of Assam i.e. Jorhat, Tinsukia, Dibrugarh, Sonitpur, Golaghat, Nagaon or anyother location decided by the authority.

Therefore, the Commissionerate of Labour, Government of Assam (GoA), proposes to empanel reputed coaching institutions to provide comprehensive coaching for aspirants preparing to aspirants preparing for various competitive examinations (Banking, SSC, and ADRE). This initiative aims to enhance access to quality education by facilitating structured and result-oriented academic support for eligible students of Assam.

2. Objective:

To empanel eligible and experienced coaching institutions capable of delivering a high standard of training, infrastructure, and mentoring to improve the success rate of selected candidates in the Banking, SSC, and ADRE competitive examinations.

3. Eligibility Criteria for Coaching Institutions:

- 1. The institution must be established under the Indian Partnership Act, 1932 / Societies Registration Act, 1860 / Companies Act, 2013 or relevant Act of the State/UT.
- Must have a minimum of 3 years' experience in providing coaching for Banking/SSC/ADRE.
- 3. Must have been fully functional for a minimum of 3 years at the time of application, with an annual enrolment of at least 2000 students each year.
- 4. Must provide residential and canteen facilities.
- 5. Must have a library with seating capacity for at least 150 students.

- 8. Must have an average turnover of ₹25 lakh over the last 3 years as evidenced by ITRs.
- 9. Must have provided services to at least 5 Government entities with valid work orders.
- 10. The cumulative value of government work orders must be above ₹50 Lacs.
- 11. The institute should not be blacklisted or terminated by any Government Department, Agency, or PSU at the time of application.
- 12. The institute must have its headquarters located in Assam.

4. Eligibility and Selection Criteria for Beneficiary Students:

- Only students who are graduates (minimum Bachelor's degree) from any recognized educational institution are eligible.
- 2. Selection will be through a qualifying entrance test under the scheme.
- 3. Each eligible student may avail the benefit only once.
- From the second year, institutions must obtain declarations from students confirming no prior availing of the benefit.
- Students must maintain a minimum of 90% attendance. Absence beyond 30 coaching days without valid reason will lead to discontinuation.

5. Responsibilities of the Coaching Institution:

- 1. Coaching must be provided for a minimum of 10 months.
- Medium of instruction: English and Assamese.
- 3. Engage qualified full-time/part-time faculty.
- 4. Ensure uninterrupted conduct of classes.
- 5. Deliver comprehensive syllabus coverage for Banking/SSC/ADRE.
- 6. Incorporate latest coaching methodologies and strategies.

6. Duration of Empanelment:

Empanelment shall be valid for a period of 1 year, subject to review based on performance.

7. Monitoring & Evaluation:

Institutes will undergo regular progress reporting, audits, and third-party evaluations by the Commissionerate of Labour, GoA.

8. Termination Clause:

Any deviation from the ToR, poor performance, or breach of obligations may lead to termination following due process.

To be considered for empanelment, coaching institutions must meet all the following mandatory technical qualifications and score at least 60 marks in the marking matrix provided:

- 1. Legal Status: Must be registered under the relevant Act.
- 2. Experience: Minimum 3 years coaching in Banking/SSC/ADRE.
- 3. Operational History: Operational for last 3 years.
- 4. Student Enrolment: Minimum 2000 per year.
- 5. Success Record: 150+ qualified students in last 3 years.
- Infrastructure: Must include residential (hostel facilities), canteen, library (150 seat).
 Rates should be adopted as per latest notification of NSDC
- 7. Turnover: ₹75 lakh cumulative in last 3 years (via ITRs).
- 8. Govt. Work Experience: At least 2 govt. projects with ₹50 lakh value.
- 9. Location: Headquarters in Assam.
- 10. Non-blacklisting: Not blacklisted or terminated by govt./PSU.

11. INSTRUCTIONS TO APPLICANT-

General Information:

- I. The Bidder must submit the EoI online on the e-procurement website.
- II. Corrupt and Fraudulent Practices Assam Building & Other Construction Workers Welfare Board requires compliance on the bidder's part with Government of Assam's policy in regard to corrupt and fraudulent/prohibited practices as set forth in this proposal.
- III. The agency has an obligation to disclose to Assam Building & Other Construction Workers Welfare Board for any situation of actual or potential conflict that impacts its capacity to serve the best interest of Assam Building & Other Construction Workers Welfare Board. Failure to disclose such situations may lead to the disqualification of the Agency or the termination of its Contract and/ or sanctions by the Government.

 - f. Tried to influence the evaluation process either directly or indirectly
 - g. Any other reason as per relevant rules or justified grounds for rejection.
