#### 1. About IREDA Limited

Indian Renewable Energy Development Agency Limited (IREDA) is a 'Navratna' Government of India Enterprise under the administrative control of Ministry of New and Renewable Energy (MNRE) that was established as a Non-Banking Financial Institution in 1987 engaged in promoting, developing and extending financial assistance for setting up projects relating to new and renewable sources of energy and energy efficiency/conservation with the motto: "ENERGY FOR EVER".

Being India's largest pure-play green financing NBFC with Over 37 years of experience of serving the Renewable Energy industry with Comprehensive suite of financial products and related services for RE Sector, IREDA has been awarded Infrastructure Finance Company status by RBI in March 2023.

IREDA has been providing financial assistance to CSR projects across the country including remote and backward area in line with the Section 135 of Companies Act, 2013 & Companies (CSR) Rule 2014 (as amended from time to time), and DPE guideline issued time to time.

**EoI - Empanelment of Agencies to conduct Impact Assessment of CSR projects****3. Scope of Work**

The following is the broad proposed scope of work under Impact Assessment study-

- i. To undertake the impact assessment studies and submit report as per the provisions of Rule 8 (3) (a) of the amended Companies (CSR Policy) Rules, for CSR Projects sanctioned by IREDA Limited throughout the country from time to time in line with the applicable guidelines from MCA and other government authorities.
- ii. The sample size and objective of the project for the impact assessment study will be based on the specific CSR project and same will be decided and informed at the time of invitation of financial bid.

**4. Validity of Empanelment**

The empanelment will be valid for 3 years from the date of 'Issuance of Letter of Empanelment'.

**5. Process of Empanelment**

Stage	Process
1	The Agency to participate in the Expression of Interest (EoI) and must meet the prescribed eligibility criteria.
2	The Agencies meeting the Eligibility Criteria will be issued Letter of Empanelment.

**6. Eligibility Criteria**

**Following are eligibility criteria for empanelment:**

Academic Organizations. Apart from the above, the following documents are required to be mandatorily provided i) Copy of PAN Card ii) Copy of GST registration iii) IT returns filed for last three immediately preceding financial years iv) Annual accounts for last three immediately preceding financial years v) RTGS/NEFT Bank Details
2	The Agency should have completed at least five (5) impact assessment studies for CSR assignments during last 5 years (i.e. FY 2019-20, FY 2020-21, FY 2021-22, FY 2022-23 and FY 2023-24) for PSUs/state government/central government organisations for CSR projects with outlays of minimum Rs. 1 crore. (The assessment/study should have been undertaken to assess the impact/outcome of a completed CSR project/activity, and the scope should broadly fall under the activities listed under schedule VII under section 135 of Companies Act, 2013)	Copies of Work Orders/ Contract agreements /completion certificates or other relevant document from client certifying that the applicant has the required experience.

**EoI - Empanelment of Agencies to conduct Impact Assessment of CSR projects****7. Methodology for award of work:**

- a) Upon empanelment, financial bids shall be invited (as and when required by IREDA Limited) for the impact assessment study from the empaneled agencies.
- b) All empaneled agencies shall be eligible to participate in the bidding process for impact assessment. However, an agency can be considered for award in maximum 03 (Three) bids at a time and award for subsequent bids can be considered only after completion of studies awarded earlier by IREDA.

8. Agencies desired to get empaneled with IREDA in terms of the EoI shall submit the application in the prescribed form with all supporting documents on or before due date for submission of EoI.

**9. Submission of EoI**

The last date for submission of **Application form along with Form – I to IV, Annexure A and Annexure-B** with all supporting documents as per eligibility criteria for empanelment shall be up to the last date for submission as per this EOI. All the pages of EOI being submitted must be sequentially numbered and signed by authorized person of the Agency.
