Early Childhood Education

Scope of Work

Background of the Project

India is home to over 13.7 lakh Anganwadi and the Integrated Child Development Scheme (ICDS) is one of the largest social initiatives by any government in the world. The focal point of the program is the Early Childhood and Care center- Anganwadi. The role of Anganwadi is critical in combating malnutrition, promoting pre- and post-natal care, immunization and early childhood education. The Anganwadi Worker (AWW) are responsible for delivering services, while a District Program Officer (DPO) oversees the implementation of the ICDS project in any district. Innovations and new projects in ICDS have resulted in the creation of projects such as ISSNIP (to address malnutrition) and programs promoting early childhood education. We, at Vedanta aim to strengthen these innovations by providing an integrated model "Nand Ghar" which provides access to quality early childhood care and education complemented with skills development. AAF for the purpose of this document, refers to Anil Agarwal Foundation.

To enhance the quality of Early Childhood Care and Education (ECCE), a training program is being planned for 1000 AWWs across Nand Ghars in alignment with Vedanta's vision to create aspirational pre-schools.

About Nand Ghar

Nand Ghar is an initiative to create and operate smart Anganwadis equipped with state-of-the-art infrastructure. These centers aim to improve early childhood education and nutrition, provide healthcare, and empower rural women through skill training. The services include early childhood education for children aged 3-6 years, nutrition, healthcare, and skill development for women.

Scope of the Services

The training will focus on equipping Nand Ghar Didis with the skills required to deliver ECCE effectively. The program's scope includes:

The training program will be implemented across Nand Ghars in Rajasthan across a few selected districts.

Content development

- 1. Content development must be aligned to the State curriculum and NEP 2020
- 2. Content must be structured in module format which can be digitized

- 3. Each module must have well defined learning objectives and outcomes that are level wise progressive
- 4. Modules must integrate the findings of needs assessment such as identification of the regional/ local content which can be used for educating children
- 5. Module content must cater to multi-media and activity-based learning approach
- 6. Content to be refreshed every quarter in consultation with Nand Ghar team

Training

- Training to be provided over the course of 12 months will comprise of a total of 10 days of non-residential training spread over 3 cycles of 3 days each and 1 day Q&A session for AWWs.
- 2. Training must be provided in batch sizes of 25-30 Nand Ghar Didis per batch
- 3. Each 3-day long training session would comprise of in-situ and classroom training.
- 4. Supportive supervision of the AWW, for the first six months after conducting the initial training to enhance & sustain the effectiveness of content delivery.
- 5. The training schedule to be finalized in consultation with Nand Ghar and the schedule to be proposed as part of the proposal.
- 6. The proposal should include a strategy for engagement with parents during PTMs / child development process.
