#### **ELIGIBILITY CRITERIA**

- 1. The training imparting organization should submit documentary evidence of having minimum 5 years' experience of providing similar type of training in related trade as mentioned in NIeT.
- 2. Training providing organization should have registered office in Howrah District having suitable training Centre(s) with adequate infrastructural facilities.
- 3. Training providing organization should be in the MSME empaneled list as approved by the Directorate of MSME, Govt. of West Bengal.
- 4. The training providing organization should have a minimum annual turnover of Rs.10 Lakhs in last two financial years.
- 5. Training providing organization should be registered under either society act/Trust act/SHG/Federation/ Co-operative Act.
- 6. The training providing organization should have to participate in the e tender in all the eight trade and if selected, the organization should impart ESDP training in all the eight trade.

#### 1. Instruction for tenderers / bidders.

A. Bidders should have Digital Signature Certificate (D.S.C.).

Necessary Earnest Money will be deposited by the bidder electronically: online – through his net banking enabled bank account, maintained at any bank or: offline – through any bank by generating NEFT/ RTGS challan from the e-tendering portal. - 2. Tenderers will have to enclose documentary proof in respect of experience as mentioned in the eligibility section of this NIeT.
- 3. Earnest Money: The amount of Earnest Money (Rs. 30760.00) by the particular bidder should be remitted through bidder's net banking enabled bank account, maintained at any bank or offline -through any bank by generating NEFT /RTGS challan from the e-tendering portal. Intending Bidder will get the beneficiary details from e-tender portal in favour of the "General Manager, District Industries Centre, Howrah", against the work.
- 4. The earnest money of unsuccessful bidders will be refunded in due course. No interest will be paid on the earnest money deposited.
- 5. The EMD deposited by successful bidder will be retained and convert





he Security Deposit will be refunded after expiry or cancellation of enlistment for sful tenderer. No interest will be paid on such security deposit.

- 6. Successful Bidders have to deposit 3 % (Three percent) of the total value of the items concerned as Performance Security Deposit. 2% of the same will be converted from the EMD (Wherever applicable) and balance 1% will be recovered/deducted at the time of payment of bills.
- 7. Exemption of Earnest Money Deposit and Performance Security Deposit will apply as per existing Government orders/rules.
- 8. Income tax or other tax / cess, if any, will be deducted at source as per Government rate and existing rules at the time of payment of bills.
- 9. The DIC, Howrah reserves the right to inspect the training Centre or office of the tenderers, if required. Tenderers who have no suitable training centre and / or office of their own at Howrah District are not eligible for the job.
- 10. Rates should be quoted inclusive of proportionate cost of all other charges like taxes (including GST), insurance, service charges, local taxes, delivery and transportation charges etc. However, the amount of GST should be specifically mentioned in the tender.
- **11. Accepted** rates should be valid for a minimum period of One year from the date of tender opening.
- 12. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.
