**Introduction:**

The Government of Karnataka have the objective to train the candidates belonging to Scheduled Caste & Scheduled Tribe candidates to prepare for competitive examinations for BANKING Probationary Officers exams. In this regard Government of Karnataka intends to depute candidates to the reputed coaching institutions who have past experience in the relevant area.

**Scope of the services:**

The Government of Karnataka intends to conduct pre-examination coaching for BANKING Probationary Officers exams for the year 2024-25. The bidder should have adequate human resources, infrastructure, study materials / digital materials experience to effectively implement the said coaching programme. The bidder should conduct class room coaching to Scheduled Caste & Scheduled Tribe candidates.

### PRE-QUALIFICATION REQUIREMENTS OF THE TEACHING INSTITUTIONS

#### Providing pre-examination coaching for BANKING Probationary Officers exams

#### I. Conditions:

1. The Coaching institute should be registered under Companies Act / Trust Act / Societies Registration Act /Partnership Act/Proprietorship act & also under GST Act.
2. There should be no legal cases of violation of any Statutory laws (Central/State) against the Institute.
3. The institute building should comply with building bye laws and fire safety requirements from concerned government authorities.
4. Teaching institute should have an excellent track record and must have been teaching for at least 3 years, in providing pre-coaching for Banking Probationary Officers exam.

5. Teaching institute should have cumulative turnover of at least Rs. 100 Lakhs in last 3 financial / assessment years i.e., 2021-2022, 2022-23 & 2023-24. (Teaching institute should upload Income tax returns for minimum 3 financial/assessment years i.e., 2021-2022, 2022-23 & 2023-24)
6. The coaching Institute must mandatorily have an own building or rented building with a minimum of 5000 square feet and adequate space in class rooms, library along with other private students and the said building should adhere to all required norms as per the disaster management Act and fire safety regulations. There must be adequate space to accommodate the IGCCD forthcoming batch in class rooms and library.
7. The coaching Institution should have excellent quality study material, developed in-house. All required good study materials should be provided to the students of the IGCCD without fail and within stipulated time.
8. The institution must have subject experts for each subject as per the BANKING EXAM syllabus (supporting documents to be provided).
9. The coaching Institute must be the original Institute. No franchise of the Institute or consortium with an established Institute is allowed to bid. The Institute should coach the candidates in house & there is no provision to train the students at a franchise / consortium.
10. The eligible candidates who are selected for the said coaching shall exercise their option for the selecting the coaching Institute of their choice for admission. No institution will get more than 20% of the cumulative target. Director, IGCCD will have the power to further reduce or increase the number of students allotted to the selected Institution based on the feedback of the students.
11. If any of the empaneled institutions are found to be not performing well, after IGCCD deputed the candidates, or if they are found to have submitted fraudulent information to the Government, then the candidates allotted to

such institutions will be re-allotted to other coaching institutions as per the student's choice within the empaneled institutions.

12. The coaching institute must upload self-declaration attested by a notary stating that the Institute / firm have not been blacklisted by Government of India / Government of Karnataka or any other Government undertakings.
13. Training Duration: – 3 Months.
14. The Evaluation of Technical and Financial bids shall be as per the KTPP Act.

**III.** The Training Institutions shall submit a check list with details of documents uploaded (i.e. for the points mentioned in I, II and III above).

**IV.** The Financial /Price bid of the Coaching Institutions which do not meet the pre-qualifying requirements of Technical Bids will not be considered.

**ii) Evaluation of Technical bids:**

- a) The evaluation of the Technical and Financial offers as per KTPP Act.
- b) The Bidders, whose technical offers are responsive against the minimum eligibility criteria, will be short listed for opening of commercial bids.
- c) The bidders whose technical offers are responsive against the minimum eligibility criteria prescribed with the minimum qualifying marks in each

of the above criteria will be shortlisted and commercial bids of such short-listed bidders only will be opened and also all compulsory/mandatory prescribed documents to be uploaded otherwise bid will be rejected summarily.

- d) The minimum qualifying marks is 60 against maximum marks prescribed 100.
- iii) Final selection of the bidder considering both Quality and cost (the feedback of the already sponsored candidates in the previous years to the bidder institution will also be examined)

More than one coaching centre (eligible in all respects only) will be selected.

**GENERAL TERMS AND CONDITIONS**  
**(Pre-examination coaching for**  
**BANKING Probationary Officers Exams)**

1. Conditional tenders are liable for rejection.
2. Intending tenderers can have detailed information from the office during office hours.
3. The tender acceptance authority / technical evaluation committee, reserves the rights to reject any or all tenders without assigning any reason.
4. The eligible candidates themselves select the coaching centres in which they want to seek coaching against the target fixed by the respective department. There is no provision for demanding more than 20% of the cumulative target.
5. If the admitted number of candidates is lesser than the candidates deployed, course fee will be paid only to those who are admitted from the respective department. If any candidate discontinues the coaching after completion of 75% of the total duration of the training, the institution will be eligible to receive entire course fee as fixed by the department for each candidate. If the candidate completes 60% of training, the institution will be eligible to receive 50% of training, if the candidate completes 40% of training, the institution will be eligible to receive 25%. If the candidate attends less than 25% of the training, no fee will be payable to the training institution, however the empanelled institution is responsible to inform IGCCD regarding dropouts if there are any.
6. The selected institutions must have bio-metric system for attendance and submit the same every month to the respective department.
7. The selected teaching Institute shall provide qualitative pre-examination training to the all candidates deputed by the Government of Karnataka as per the syllabus notified / prescribed.

8. The teaching institute should conduct at least one test series once in a month and 2 main tests (total 5) during the training period and submit the results to the respective department.
9. Teaching Institution should provide quality study material for each candidate.
10. The duration of the training programme will be 03 months.
11. Rate negotiation will be done by the tender accepting authority/committee.
12. The selected teaching institute should not sublet the contract. If the teaching institute is found to have sublet the contract, the contract will be terminated at the risk and cost of the teaching institute concerned.
13. The selected Institution shall enter into a contract agreement on a non-judicial stamp paper of Rs.500/- (Rupees five hundred only) with terms and conditions as per the format specified by the government, within 07 days from the receipt of written communication of letter of acceptance to this effect failing which the EMD will be forfeited.
14. Course fee will be paid in three installments, first installment of 30% of total amount will be released after the completion of 1 month training and second installment of 40% of total amount will be released during middle of the training period. The third and final installment of 30% will be released after the successful completion of training.
15. **Penalty clause:** The successful bidder must provide all the resource manpower from the date of starting of coaching, failing in which penalty at the rate of Rs.100/- shall be charged per day per candidate. After which work order will be cancelled. In addition, forfeiture of performance security deposit will also be considered.

16. The Director, IGCCD, Bengaluru, including the authorized officers of the concerned department shall have the power to inspect the institution and issue notice in writing and to instruct/direct the Institution to make alterations/variations/any updates in the assigned work.

17. Evaluation of Technical and Commercial Proposal:

A. Evaluation of Technical Bids -

A Tender scrutiny committee will be formed by government for evaluation of the bids. The committee would evaluate both Pre-qualification cum Technical bids based on the details provided in the RFP and the committee shall seek the bidders to make a technical presentation on a specified date and time. Decision of the committee would be final and binding upon all the Bidders. The commercial proposal of those bidders found pre-qualified and technically qualified will be opened.

B. Financial Evaluation -

The Commercial Bids of only the technically qualified bidders will be opened for evaluation. The rates will be negotiated by the Tender accepting authority/ tender evaluation Committee.

18. All disputes arising out of this contract will be within the jurisdiction of the courts in Bengaluru city.

19. Failure to abide by the Agreement:

The conditions stipulated in the agreement shall be strictly adhered to and violation of any of the conditions will entail termination of the contract without prejudice to the rights of the government with such penalties as specified by the Agreement.

20. Confidentiality of the Document:

This Tender Document is confidential and the Social Welfare Department shall ensure that anything contained in this Tender Document shall not be disclosed in any manner, whatsoever.

21. The successful bidder shall furnish performance Security within 15 days from the date of signing the agreement at 5% on contract value in the form of DD drawn in favour of concerned departments or bank guarantee having validity for the entire period of coaching i.e., from the date of issue of work order. The tender inviting authority / committee reserves the rights to get the security deposit/Bank guarantee extended for further period based on the extension of the service.

22. Appeal: Any tenderer aggrieved by an order passed by the tender accepting authority may appeal to the prescribed appellate authority within seven days from the date of receipt of such order or rejection/disqualification.

23. Rejection Criteria:

Besides other conditions and terms of the tender document, bids may be rejected under following circumstances.

A. Pre-Qualification cum Technical Rejection Criteria.

- If the information provided by the Bidder is found to be incorrect / misleading at any stage / time during the Tendering Process / afterwards.
- Any effort on the part of a Bidder to influence the bid evaluation, bid comparison or contract award decisions.
- Bids without signature of person (s) duly authorized on required pages of the bid.

- Bids without power of authorization and any other document consisting of adequate proof of the ability of the signatory to bind the Bidder.
- Failure to furnish proofs for information provided.
- Bidders shall ensure that original documents are scanned and uploaded in the slots specified in e-procurement portal.
- Revelation of prices in any form or by any reason before opening the commercial Bid.
- Failure to furnish all information required by the RFP (Request for proposal) document or submission of a bid not substantially responsive to the Tender document in every respect.
- Bidders not complying with the Technical and General Terms and Conditions as stated in the RFP.
- The Bidder not conforming to unconditional acceptance of full responsibility of providing services in accordance with the Agreements of this tender.
- If the bid does not confirm to the timelines indicated in the bid.

B. Commercial Rejection Criteria.

- Incomplete Price Bid.
- Price Bids that do not conform to the Tender's price bid format.
- Total price quoted by the Bidder shall not include all statutory taxes and levies applicable.
