

कंत्राटदाराने शासकीय विमानिधीपाशी कंत्राटकामाचा विमा उतरवावा म्हणून करारनाम्यात समाविष्ट करावयाच्या अटीचे प्रारूप

कंत्राटदारावर सोपविलेल्या कंत्राटकामाचा विमा कंत्राटदारांनी विमा संचालनालय, महाराष्ट्र राज्य गृहनिर्माण भवन २६४, पहिला मजला, कलानगर, बांद्रा (पूर्व) मुंबई ४०००५१ (दूरध्वनी क्र. ६४३८४०३ / ६४३८६९० व फॅक्स क्रमांक ६४३८४६१) या कार्यालयापाशी कंत्राटाच्या संपूर्ण रकमेस व कंत्राटाच्या पूर्ण कालावधीस उतरविणे आवश्यक आहे. तसेच कंत्राटी काम पूर्ण करण्यासाठी नियुक्त करण्यात येत असलेल्या सर्व कामगारांचा विमा कामगार नुकसान भरपाई विमापत्राखाली उतरविणे अनिवार्य आहे. विमा संचालनालयाच्या व्यतिरिक्त अन्य विमा कंपन्याकडून घेतलेली विमापत्रे स्वीकारली जाणार नाहीत.

(Draft of Proposed condition relating to Insurance of Contract Works)

Contractor shall take out necessary Insurance Policy / Policies so as to provide adequate insurance cover for execution of the awarded contract work for total contract value and complete contract period from the "Directorate of Insurance, Maharashtra State, Mumbai" only. Similarly, all workmen's appointed to complete the contract work are required to insure under workmen's compensation Insurance Policy. Insurance policy / policies taken out from any other company will not be accepted. If any contractor have effected insurance with any Insurance Company, the same will not be accepted and the amount of premium calculated by the Directorate of Insurance will be recovered directly from the amount payable to the contractor for the executed contract work.
