3. BACKGROUND

Himachal Pradesh School Education Society (HPSES) is a registered society under the Societies Registration Act, 2006. Its primary mandate is to implement Samagra Shiksha in the state of Himachal Pradesh. Samagra Shiksha is a comprehensive scheme for school education that views the "school" as a seamless journey encompassing pre-school, primary, upper primary, secondary, and senior secondary levels. The objective of this scheme is to provide inclusive and equitable quality education from pre-school to senior secondary stage, aligning with the Sustainable Development Goal (SDG) for Education.

4. PREAMBLE

The objective of this training program is to empower girl students to combat crime effectively. Unfortunately, even in today's modern era, violence against girl students remains prevalent. Therefore, it is essential for girl students to acquire self-defense techniques. Under the guidance of experienced and supportive martial arts instructors, provided by Samagra Shiksha, girl students will have the opportunity to learn practical self-defense techniques in a safe environment. This program not only enables them to relieve stress and maintain physical fitness but also equips them with invaluable skills to protect themselves.

This program offers a unique blend of physical fitness and practical self-defence techniques, specifically designed to benefit girl students. With the aim of empowering girl students attending government schools in Himachal Pradesh, under the Samagra Shiksha, is committed to providing realistic and effective Self Defence Training. Through this training, girl students will gain awareness, learn prevention strategies, understand risk reduction and avoidance, and discover their own physical capabilities. These self-defence techniques significantly enhance personal protection options, enabling them to effectively respond to potentially dangerous situations and boosting their confidence in their daily activities. This training program aims to accomplish short-term goals of self-protection while fostering the long-term objective of attaining a black belt in martial arts for self-defence.

In this context, school-going girl students are the most vulnerable and susceptible to various challenges. Often, these girls have to undertake long and solitary journeys from their homes to reach secondary or higher secondary schools, relying on modes of transportation such as walking, cycling, or taking the bus. Due to concerns for their safety, parents tend to restrict the regular attendance of their daughters in schools. This situation increases the likelihood of girls dropping out from secondary or higher secondary schools.

Samagra Shiksha, Himachal Pradesh is actively seeking eligible organizations/firms specialized in self-defence training programs to serve as partners for the comprehensive rollout of the training. The aim is to outsource the entire training delivery process to these partners, who will be responsible for providing qualified training instructors to deliver self-defence training in selected government schools across Himachal Pradesh.

By issuing this RFP, Samagra Shiksha aims to identify and select partners who will offer a Six month Self-Defence Training Program under the Samagra Shiksha for girl students attending government schools in Himachal Pradesh. It's important to note that the final allocation of schools may vary during the selection process.

5. AIMS & OBJECTIVES OF THE PROGRAM

- Self-defence training empowers girls by strengthening them psychologically, intellectually, and physically, enabling them to protect themselves during moments of distress and vulnerability.



- The objective is to provide girls with essential self skills that enable them to effectively navigate and prevent any uncomfortable situations right from the outset.
- The aim is to send a strong message to potential perpetrators of violence that girls are prepared to counter such acts, while simultaneously fostering a culture of awareness among girls regarding self-protection.
- The primary objective is to empower girl students comprehensively, addressing all aspects of their development and well-being.
- The goal is to enhance the regular attendance of girl students in secondary schools, promoting consistent and uninterrupted educational participation.
- The objective is to create awareness among Physical Education teachers in each school about these essential skills, enabling them to incorporate and integrate them into the school curriculum for future practice.

Upon successful financial bid, it is necessary to enter into a suitable agreement with Samagra Shiksha. However, if the agency finds the terms and conditions of the agreement unacceptable, Samagra Shiksha reserves the right to reject the agency.

- c. **Right to Rejection:** Samagra Shiksha reserves the authority to reject any or all applications at any stage without providing any reasons whatsoever.

10. QUALIFICATION OF MASTER TRAINERS & SCOPE OF WORK:

a. Qualification of Master Trainers whose service shall be provided to Samagra Shiksha

- A minimum of six month's certification course or martial art training experience certificate, along with a rank (belt) holder status, in at least one of the following styles/forms of martial arts for self-defence must be obtained from a certified organization.
 1. Taekwondo
 2. Wushu
 3. Karate
 4. Judo
 5. Western boxing
 6. Kickboxing
 7. Muay Thai
 8. Jiu-Jitsu (or Jujutsu)
 9. Krav Maga
 10. Aikido
 11. Jee Kune Do
- The minimum age requirement is 18 years or older.
- Proficiency in at least one of the aforementioned skills of Martial Arts for self-defence is required.
- Sound physical and mental health is essential.
- Candidates must not be addicted to drugs, alcohol, smoking, or any similar substances.
- The master trainer should uphold a high standard of moral conduct and there should be no criminal or sexual harassment cases against them.

Note: The master trainer must not be an employee of the Samagra Shiksha or Government of Himachal Pradesh.



b. Scope of Work

The self-defence training program for female students will be conducted in a total of 4745 elementary and secondary/senior secondary schools across all districts of Himachal Pradesh.

- The successful bidder will be responsible for providing an adequate number of experts (based on district-wise requirements) who possess the aforementioned skills and qualifications in at least one specialized form of martial art for self-defence. Each specialized trainer will conduct training sessions in one or more allocated schools, focusing on a specific style/form of martial art for self-defence.
- The successful bidder must submit a district-wise list of trainers specializing in specific form/forms of martial art along with their bid submission, following the format provided in Annexure-9.
- The successful bidder must submit self declaration certificate in r/o girls students safety and security.
- At given stage, Samagra Shiksha retains the prerogative to modify the change of Schools by a range of 5% to 10% in either direction, with no financial consequences.

- a) The Financial proposals should be submitted as per the format of Financial Bid given at Annexure 7. Adherence to the prescribed format and terms as mentioned in this RFP must strictly be followed. Any deviation from prescribed format of the financial bid, will result in disqualification of bid.
- b) The prices submitted in the financial bid should be inclusive of all taxes and duties as applicable. The volumes specified in the Financial Bid are for evaluation purposes and not a commitment from Samagra Shiksha. The figures are bound to change based on various circumstances.
- c) Unless expressly indicated, Bidder shall not include any technical information regarding the services in the Financial Bid.



- d) Prices shall be quoted entirely in Indian Rupees and must include all applicable taxes and levies.

In the event that the fixed date for bid opening is declared a holiday by the Government, a revised schedule will be announced. However, in the absence of such notification, the bids will be opened on the next working day, with the time remaining unchanged.
- b) **Part-A:** The suitability of organizations will be evaluated to determine their eligibility for selection. If they are deemed suitable, they will be selected based on the eligibility criteria outlined in clause 12 Part-A, as well as the scope of work mentioned in clause 10(a) and (b).
- c) **Part-B:** The financial proposals will only be opened for agencies that are deemed technically eligible and qualified.
- d) **Payment terms :** Payment will be made in accordance with the terms and conditions specified on the RFP, contingent upon the submission of a certificate from the district officers confirming the successful completion of training.
