- 4. Discipline of the Scheme :-
 - Centrally awarded Pradhan Mantri Poshan Shakti Nanman Yojana has been launched since November 22, 1995
 to privatize primary education, increase enrollment and participation of new students in schools and stop
 dropout of new students in schools. The beneficiaries of Pradhan Mantri Poshanshakti Nanman Yojana are
 the beneficiaries of Pradhan Mantri Poshanshakti Nanman Yojana, who are studying from class 1st to 8th in
 Central and State Government, Local Self-Government, Private Institutions Granted/Partially Granted Schools,
 Vastishalas, Mahatma Phule Education Guarantee Scheme Centres. 100 out of 85,761 schools in the state at present
 The benefits of the scheme are being given to Lakshadweeps.
 - In the year 2001 Hon'ble Supreme Court to new applicants in Pradhan Mantri Poshanshakti Nanman Yojana

 No instructions were given to give cooked food in the school instead of dry rice. Accordingly, since the year

 2002, the students are being given the food provided in the form of mid-day meal in the school itself.
 - According to the guidelines of the central government, under this scheme, mid-day meal containing 450 calories and 12 grams of proteins is given to the beneficiaries of classes 1st to 5th. Also, mid-day meal containing 700 calories and 20 grams of protein is given to new students of 6th to 8th standard.
 Government rice is transported by the supplier to the schools where kitchens are available in the state and the grain is supplied by the supplier itself. The food is cooked and given to the students through the school-level food preparation system.
 - Cooked food is supplied through the central kitchen system of Savings Groups/NGOs/Non-Governmental
 Organizations at the school level where kitchens are not available in the area of Mahanagara Panalka/Nagar
 Panalka/Katakamandal, 5. Form of Work:-

Under the Pradhan Mantri Poshan Shakti Nanman Yojana, organizations are to be appointed to provide training to cooks and helpers as per the Food Safety Standards Act 2006.

- V. Cooks and helpers working in the water in the presence of the Divisional Officer

- V. The organization has experience, knowledge, skills to provide training as per Food Safety Standards Act, 2006.
 Manpower and adequate staffing is a major constraint.
- VI. Any criminal case filed against the Laboratory / Institute or any office-bearer of the Institute /

There should be no procrastination.
