INTRODUCTION:

We are an industry-led apex body, jointly set up by the Cellular Operators Association of India (COAI), Indian Cellular and Electronics Association (ICEA) and National Skill Development Corporation (NSDC), to ensure adequate availability of skilled manpower to boost growth and productivity in the Telecom sector.

Over the years, TSSC has emerged as the bridge between Ministries, Indian telecom industry and youth of our nation for skill development. TSSC works with several Ministries, Skilling bodies, technical institutes with the objective of promoting skills amongst young Indian talent and bridging the manpower demand - supply gap in the industry. SCOPE OF WORK:

Telecom Sector Skill Council has been allocated target of 15000 candidates under Short-Term Training under Special Project (Captive Placement with Industry) under PMKVY 4.0 towards Fiberzation in India.

Under the said project candidates shall be trained in five job roles by through its TSSC CEO / PMKK's / Industry Partners / Training Partners.

Independent Training Centres shall be created towards the implementation of this project, dedicated labs. in selected job roles shall be created.

Following conditions must be complied with before initiation of any batch:

1. Bidders should strictly follow the latest Guidelines for Accreditation, Affiliation & Continuous Monitoring for the PMKVY 4.0 CSCM – Special Projects.
2. Bidders should strictly follow the latest Branding and Communication guidelines of PMKVY available at <http://pmkvyofficial.org/> under the Guidelines section.
3. Training Partner / Industry partners should ensure social media presence and engagement via Twitter and Facebook. SPIA should ensure compliance with social media guidelines, available on the PMKVY website. It is mandatory to put up posters of the job roles available at the Centre in respective classrooms and labs as they impart essential information, which may help candidates in making well-informed career decisions.

5. All the mobilization efforts should be conducted immediately keeping in mind the MoHFW guidelines on Covid-19. The information regarding these activities must be captured and shared with NSDC immediately. Report must be maintained for all mobilization activities with photographic evidence.
6. Installation of Aadhar-Enabled Biometric Attendance System (AEBAS) / NSDC's PMKVY Attendance Management System App for capturing attendance is a mandatory requirement.
7. Bidders must comply with PMKVY guidelines pertaining to Training of Trainer (ToT) for initiation of training.

ADDITIONAL INFORMATION:

1. E-KYC would be done for candidates.
2. No fee to be collected from candidates and no incentive to be provided to candidates.
3. OJT hours will be added at scheme level if the same do not exist in QPs and number of hours will be based on SSC recommendation. The industry/TP certificate will upload as proof of OJT. The OJT will be physically checked once, and uploaded documents will also be checked. Any anomaly noted will be taken up for penal action.
4. For Special Projects, training payout to be made in two (40:60). Final payments will be on number of certifications.
5. 1-year tracking would be done for all Special Projects candidates. The method will be specified separately.

EARNEST MONEY DEPOSIT (EMD) / SECURITY DEPOSIT (SD):

The successful Bidder shall have to submit of Rs. 1,00,000 (Rupees One Lakh Only), before the release of the Work Order. The EMD / SD has to be submitted only through internet banking through a Nationalised Bank in the favour of Telecom Sector Skill Council. (The details for the same shall be shared with the selected bidders separately)

In case the bidder fails to complete the assigned target as per the specified timelines or in case of non-compliance of the project deliverables or meet the project guidelines or found to indulged in any kind of unethical practices will lead to immediate termination of this Work Order and the submitted EMD / SD will be forfeited.

Refund of EMD / SD: The same shall be refunded after successful completion of the assigned target. (On approval from Project Implementation Committee)

4. Must have imparted training to at least 500 candidates under PMKVY/ ESDM or any government sponsored scheme.
5. The company should not have been blacklisted by any Government Body/ PSU/ Department.
6. The company must accept in writing towards adherence of all schemes related guidelines as and when applicable.
7. Copy of 2 direct Work Order to the organisation for any government sponsored training program to be attached.
8. The company must have at least 10 regular employees.
9. Optional* Details to be provided for training conducted in Telecom job roles.

These are not limited conditions, in case Bidder missing the above criteria may apply, the same shall be evaluated by a four TSSC Member Committee constituted for proposal evaluation and approval.
